

# POLICY 04 CHILD PROTECTION

The daily life of the college will be permeated with the values of Jesus Christ and the teachings of the Catholic Church. Special links will be maintained with the Sisters of Our Lady of the Missions as the College Founders and their special charism reinforced in the College.

## 1.0 Purpose and Scope

The Board of Trustees has an obligation to ensure the wellbeing of children in our care so they thrive, belong and achieve. We are committed to the prevention of child abuse and neglect and to the protection of all children. The safety and wellbeing of the child is our top priority. Advice will be sought through appropriate agencies in all cases of suspected or alleged abuse.

This policy outlines the board's commitment to child protection and recognises the important role and responsibility of all our staff in the protection of children. It includes the Board's expectations when child abuse is reported or suspected by us. All staff members (including contractors and volunteers) are expected to be familiar with this policy, its associated procedures and protocols and comply with them.

In line with section 15 of the Children, Young Person and Their Families Act (Vulnerable Children's), 2014, any person working at Sacred Heart Girls' College, who believes that a student has been, or is likely to be, harmed (whether physically, emotionally, or sexually) ill-treated, abused, neglected, or deprived, must follow school procedures; they may also report the matter to Oranga Tamariki or the local Police.

Although ultimate accountability sits with the Board, the Board delegates responsibility to the Principal to ensure that all child safety procedures are implemented and available to all staff, contractors, volunteers and parents.

## 2.0 Guideline

Therefore, the Principal must:

- 2.1 Develop appropriate procedures to meet child safety requirements including guidelines and systems for safety checks.
- 2.2 Comply with relevant legislative requirements and responsibilities.
- 2.3 Make this policy available on the School's website and available on request.
- 2.4 Ensure that every contract or funding arrangement into which the school enters has appropriate child protection policies in place.
- 2.5 Ensure the interests and protection of the child are paramount in all circumstances.
- 2.6 Recognise the rights of family/whanau to participate in the decision-making about their children.
- 2.7 Ensure that all staff are able to identify the signs and symptoms of potential abuse and neglect, deal with disclosures by children and allegations against staff members and are able to take appropriate action in response.

- 2.8 Make available professional development, resources and/or advice to ensure all staff can carry out their roles in terms of this policy.
- 2.9 Support all staff to work in accordance with this policy, and work with partner agencies to ensure child protection policies are understood and implemented.
- 2.10 Promote a culture where staff feel confident they can challenge poor practice or raise issues of concern without fear of reprisal.
- 2.11 Consult, discuss and share relevant information, in line with our commitment to confidentiality and information sharing protocols, in a timely way regarding any concerns about an individual child with the Board or designated person.
- 2.12 Seek advice as necessary from NZSTA advisors on employment matters and other relevant agencies where child safety issues arise.
- 2.13 Ensure that this policy forms part of the initial staff induction programme for each staff member.
